| 15 | WHEREAS, Tribal law prohibits Tribal officials and certain employees from being TERO certified and from contracting with the Tribe; and |

| 18 | WHEREAS, the prohibition is in place to prevent conflicts of interest and sweetheart deals in the |
| 19 | award, oversight, and payment of contracts; and |
| 20 | WITEDEAS the muchibities is incomposed in Section 2.10 of the Democrated Delice, which states |
| 21 22 | WHEREAS, the prohibition is incorporated in Section 2.19 of the Personnel Policy, which states that Tribal employees may hold outside jobs so long as the outside jobs do not |
| 23 | interfere with their Tribal employment, the outside job does not bring discredit on |
| 24 | the EBCI, and the outside job does not constitute a conflict of interest; and |

| 26 | WHEREAS, there is no dispute about the intent and efficacy of the prohibition when it is applied |
| 27 | to elected officials and higher-level appointed officials; and |

| 29 30 | WHEREAS, the prohibition, however, can impose a hardship on other employees who have become Tribal employees after forming an outside business as a sole proprietor or a |
| 31 | closely-held business that provided services to Tribal members and their families; |

| 34 | WHEREAS, Tribal law should be amended to remove the prohibition for Tribal employees |
| 35 | below the level of Division Secretary who may want to contract with the Tribe to |
| 36 | provide desired services to Tribal families on the Qualla Boundary. |
| 37 38 | NOW THEREFORE BE IT ORDAINED by the Eastern Band of Charakte Indiana in Tribal |
| 39 | NOW THEREFORE BE IT ORDAINED by the Eastern Band of Cherokee Indians in Tribal Council assembled, at which a quorum is present, that amend Cherokee Code |
| 40 | Sections 92-10 and 117-45.3 shall be amended to read as follows: |
| 41 | Sec. 92-10. Certification requirements. |

| 42 43 | (a) To be certified as an Indian owned economic entity entitled to a preference under this Chapter the following requirements shall be met. |
| 44 45 | (1) The economic entity shall be at least 51 percent unconditionally owned and controlled by a member of a federally recognized Indian tribe or a married couple in which one |

- spouse is a member of the Indian tribe and be able to provide documentary evidence of that ownership.
- 3 (2) The economic entity shall maintain a valid, current Tribal business license.
 - (3) The economic entity or persons within the entity, whichever is appropriate, shall at all relevant times maintain the professional licenses, registrations and certifications required by applicable law.
 - (4) Reserved.

- (5) The economic entity shall have a business plan that contains a formal statement of a set of business goals. If all goals have not been met give the reasons why they are believed attainable, and the plan for reaching those goals. The plan may contain goals that follow the ideals set forth within this Chapter. It may also contain background information about the organization or team attempting to reach those goals.
- (6) The economic entity shall at all relevant times maintain adequate capital to sustain its operations and carry out its business plan.
- (7) The economic entity shall have a record of successful performance on contracts in the trade for which it wants to be certified.
- (8) The economic entity shall have at least three verifiable references from persons for whom it has performed work in each trade in which it wants to be certified.
- (9) The economic entity shall have, for each specific trade for which it wants to be certified, the capacity to perform 50 percent of any job it is awarded with its own personnel, equipment and facilities and the ability to timely obtain, as "timely" is defined by the procuring entity, additional necessary personnel, equipment and facilities to perform contracts if awarded certification.
- (10) The economic entity and its principals shall submit to and pay for the following background checks, which may be requested or performed by the Commission upon submission of an application to the Commission or at any time after certification:
 - a. Licensing history.
 - b. Criminal history.
 - c. Debt and credit history.
 - d. Litigation involving the economic entity and/or principals as defendants.
 - Such background checks shall be completed by entities acceptable to TERO as set out in its policies and procedures.
- (11) An economic entity shall have been operational for at least one year in the trade in which the economic entity wants to be certified. An economic entity shall also have been operational for at least one year in any areas of trade they add later and shall provide additional business plans for the additional areas they seek to be certified in later.
- (12) The economic entity shall have the following minimum insurance:

- 1 a. Workers compensation insurance as required by law in the State of North Carolina;
 - b. General liability insurance sufficient to meet Tribal contracting requirements;
 - c. Vehicle insurance;

- d. At the time of applying for certification, the economic entity shall show proof of insurance coverage sufficient to meet Tribal contracting requirements; and
- e. The Commission may require more or additional insurance including, but not limited to, professional liability or malpractice insurance.
- (13) The economic entity shall be inspected by an official of the TERO to ensure that the economic entity possesses, has leased or has the ability to lease the material, equipment, tools and/or personnel required to perform the economic entity's daily business functions.
- (14) The principals of the economic entity shall attend an annual TERO training session hosted by TERO.
- (b) If, at any time, an economic entity fails to meet the requirements imposed in this section the Commission shall, after a hearing, suspend the economic entity's certification and give it an opportunity to meet the requirements. Repeated failure to meet requirements will result in termination of certification.
- 19 (c) Any elected officials, Executive <u>Office</u> staff, <u>Program Directors Division Secretaries</u>, and currently seated members of other Boards and Commissions that receive monetary compensation may not be TERO-certified.

- 23 (a) Tribal officials shall not take any official action or participate in the selection, award, or administration of a contract or grant award, if a conflict of interest, real or apparent, shall be involved.
- (b) Tribal officials shall not directly or indirectly solicit, accept or provide gratuities, favors, or anything of monetary value from contractors, potential contractors or subcontractors who are contracting to perform services or sell goods or property to the Tribe or a Tribal program.
- 30 (c) Tribal officials, directly or through a business entity in which the Tribal official has a 31 personal interest, shall not enter into any contract for services or goods with any Tribal 32 entity, enterprise, or program for the purpose of either receiving or providing services or 33 goods. This provision shall not apply to such persons Tribal officials qualifying for 34 programs available to all Tribal members. Further, this provision shall not apply to Tribal 35 officials who obtained their position by appointment and who are employed below the level 36 of Division Secretary, provided, however, that this exception applies only if the contracting 37 person and the Tribal Division and program in which they work do not have any approval or 38 oversight authority over the contract.
- (d) Tribal officials shall treat service to the EBCI as a sacred public trust with fiduciary
 responsibility, which requires upholding and acting in accordance with laws and engaging

- in the proper governance of the EBCI in a manner, which is placed above personal and private gain.
- 3 (e) Tribal officials shall protect and conserve Tribal resources and ensure the appropriate use of Tribal resources falling under the scope of the office of the Tribal official.
- 5 (f) Tribal officials shall provide every enrolled member a time to be heard on a Tribal issue that falls under the scope of the Tribal official's duties. This paragraph shall not supersede C.C. Section 117-16.
- 8 (g) Tribal officials shall not use their authority, title, or influence to improperly advance personal or financial interests.
- 10 (h) Tribal officials shall disclose instances when they believe there has been fraud, waste, 11 abuse, corruption, or violations of this chapter to the Office of Internal Audit and Ethics.
- 12 (i) Tribal officials shall respect and honor the customs and traditions of the EBCI.
- 13 (j) Tribal officials shall abide by the laws of any sovereign jurisdiction in which they are 14 present. Tribal officials shall disclose any misdemeanor or felony charges and/or 15 convictions that occur in any jurisdiction while in office to the Office of Internal Audit and 16 Ethics.
- 17 (k) Tribal officials shall report to the Office of Internal Audit and Ethics, in accordance with that office's rules of procedure, any gift, donation, or contribution received or provided by the Tribal official.
- 20 (l) Tribal officials shall not act individually, jointly, or through another, threaten, intimidate, or discipline any person as reprisal for any legitimate action taken by the person.
- 22 (m) Tribal officials shall not offer, solicit or accept, directly or indirectly, anything of value if 23 the gift could reasonably be expected to influence the vote, official actions, or judgment of, 24 or for, the official or could reasonably be considered a reward for any official action or 25 inaction.
- 26 (n) Tribal officials shall not withhold materials or information from the public pertaining to those items discussed in closed session unless such materials or information are deemed exempt from disclosure in accordance with Chapter 132 of the Cherokee Code.
- 29 (o) Tribal officials shall not take any official action or participate in a decision with respect to a
 30 matter if it will have a direct and predictable effect on the financial interest, personal
 31 interest, or present a conflict of interest for the official or employee or his or her immediate
 32 family member. Any official in such situation shall recuse himself or herself from
 33 participating in a discussion and/or vote on the matter giving rise to such conflict.
- (p) Tribal officials may participate in private, public, civic, and/or charitable activities provided
 such activities do not compromise the integrity or reputation of the EBCI or interfere with
 the performance of official duties.
