10	An ordinance to amend C.C. Section 17-12 to provide that the Cannabis Control Board shall
11	select a member of the Board to serve as its Chairman.

14	WHEREAS, Cherokee Code (C.C.) Chapter 17 establishes and governs the Cannabis Control
15	Board ("CCB"); and
16	
17	WHEREAS, C.C. Section 17-12 expresses the terms of the members appointed to the CCB, who
18	are nominated by the Principal Chief; and
19	WHEREAS, Section 17-12 should be amended to clarify that the persons nominated by the
20	Principal Chief are subject to confirmation by Tribal Council, that they may serve
21 22	until their replacement is appointed, and to express that the members of the Board
23	shall select one of the Board members to serve as Chairman of the Board.
24	shall select one of the Board memoers to serve as Chamman of the Board.
25	NOW THEREFORE BE IT ORDAINED by the Eastern Band of Cherokee Indians in Tribal
26	Council assembled, at which a quorum is present, that C.C. Section 17-12 shall be
27	amended to read as follows:

29	Sec. 17-12. Terms, chair, removal.

31	(a) The term of office of each member of the Board is four years, provided, however, that each
32	Board member may serve until their replacement is confirmed and appointed.

34	(b) The Principal Chief shall nominate the members of Board, who shall be subject to
35	confirmation by Tribal Council. and designate one member to serve as Chair, who shall
36	preside over all official activities of the Board.

1 (2) A public hearing before Tribal Council is held upon the charges, if requested by the member charged. The request for a public hearing must be made to the Chair of Tribal 2 Council within ten days after service upon such member of the charges. If a hearing is not 3 requested, a member is removed effective ten days after service of charges upon the member. 4 A record of the proceedings at the public hearing must be open to public inspection. 5 6 7 BE IT FINALLY ORDAINED that all ordinances that are inconsistent with this ordinance are rescinded, and that this ordinance shall become effective when ratified by the 8 Principal Chief. 9 10
