RESOLUTION NO. 208 (2026)

*A resolution to exclude Jackie Lynn Beck from the lands of the  
Eastern Band of Cherokee Indians.*

WHEREAS, the Eastern Band of Cherokee Indians (“EBCI” or “Tribe”) has the sovereign authority to exclude persons from lands of the Eastern Band to protect the integrity, law and order of the lands, and the welfare of Tribal members; and

WHEREAS, the Tribal Council has codified its authority to exclude persons from the lands of the Eastern Band at Chapter 2 of the Cherokee Code; and

WHEREAS, the power to exclude is an inherent and essential part of Tribal sovereignty that is indispensable to the Tribe's autonomy and self-governance; and

WHEREAS, JACKIE LYNN BECK (Date of Birth: 02/03/1978) is not a member of the Eastern Band of Cherokee Indians; and

WHEREAS, BECK has a criminal history including being on probation in Swain County NC. BECK has been charged with felony possession of schedule II controlled substance and possession with the intent to manufacture, sale or deliver a schedule II controlled substance; and

WHEREAS, BECK has also been charged in Tribal Court for first degree burglary, larceny, and child abuse in second degree; and

WHEREAS, on 02/04/2026 BECK was charged with felony possession of methamphetamine and possession of drug paraphernalia. BECK had in her possession, .4 grams of methamphetamine along with a glass smoking device and a set of digital scales.

WHEREAS, BECK does not appear to have any legitimate business upon the Qualla Boundary. It is believed that BECK poses a threat to the health, welfare, and safety to the members of the Eastern Band Of Cherokee Indians.

1 NOW THEREFORE, BE IT RESOLVED by the Tribal Council, in Council assembled  
2 with a quorum present, and with the number of votes required by Tribal  
3 law, JACKIE LYNN BECK is hereby PERMANENTLY EXCLUDED  
4 from all Tribal lands and is hereby notified and ordered to vacate all tribal  
5 lands.

7 BE IT FURTHER RESOLVED that this permanent exclusion prohibits  
8 JACKIE LYNN BECK from entering or being present on Tribal  
9 Land for any purpose except as required by Tribal Council or Tribal Court.

11 BE IT FURTHER RESOLVED that if JACKIE LYNN BECK  
12 is found improperly on Tribal lands at any time after the effective date of  
13 this resolution, she shall be treated as a trespasser and appropriate legal  
14 action shall be taken against her.

16 BE IT FINALLY RESOLVED that all resolutions inconsistent with this resolution are  
17 rescinded, and that this resolution shall become effective when ratified by  
18 the Principal Chief.
